Dear Parent/Carer

Re: Relationships Education (primary) and Relationships and Sex Education (secondary)

As part of the school's curriculum, your child will be receiving Relationships Education (primary), Relationships and Sex Education (secondary). These lessons will be tailored to your child's ability and understanding by their class teacher. Class Teachers will share the curriculum content with parents at the start of each term.

The purpose of RSE is to provide knowledge and understanding of how the human body changes during puberty and the processes of human reproduction, within the context of relationships based on love and respect. Our curriculum will cover all kinds of relationships, such as with family members and friends as well as romantic. Relationships education and Relationships and Sex Education is important for the safeguarding of all children and young people.

If pupils are provided with timely and appropriate information about their bodies and relationships, they can make their transition into adulthood with the confidence and knowledge to understand what is happening to them and grow into confident and healthy adults able to make positive choices.

Parents can no longer withdraw their child from Relationships Education, or any element of sex education that is covered within the national curriculum subject Science. Neither can children be withdrawn from health education which includes learning about puberty. Parents do have the right to withdraw their child from Sex Education content of RSE. This request should be made in writing to The Headteacher expressing the reasons withdrawal should be considered.

Our RSE Policy is available to access on our website. The focus of RSE at GANF is to encourage meaningful discussion about feelings, relationships and values, as well as understand the physical aspects of sex and reproduction (if appropriate to individuals) and we value the input from parents and carers.
